It is easy to see the obstacles in 2020, however Allen County had many wins in the last year.

Over \$250 million in capital investments were made and more than 260 jobs created by our largest existing companies in 2020. About \$100 million in new construction will be completed in 2021. Building permit applications totaling 3,303,117 square feet were requested in Allen County from January through November of this year. That was an increase of nearly 60% over all of 2019.

A quick review of some of the projects:

**Logoplaste:** Portugal-based plastics manufacturer, 100,000 sf, \$35 million investment, 51 new jobs

**Randall Bearings:** 90,000 sf facility for Lima company, \$6.5 million investment, 87 jobs retained

**Beer Barrel:** New location with 11,000 sf, \$3.5 million investment, 52 FTE jobs

**Perry ProTech:** New 50,000 sf headquarters, \$6.1 million investment, 78 jobs retained, 6 new jobs

**Rhodes State:** 50,000 sf training center, \$20.2 million investment

Mercy Health: 48,000 sf training center, \$15 million investment.

Another bright spot in 2020 was the inception of the JobsOhio Inclusion Grant program. The grants were available to small businesses located in distressed zip codes that needed some gap funding for a planned project. Seven area businesses received a total of \$250,000, resulting in 25 new jobs and the retention of 130 jobs. Funding went toward the purchase of new machinery to increase each company's capabilities and services offered.

Expectations are for a return to full capacity in all aspects of life during 2021. Goals for the year include secured funding and a development plan for a speculative building along Commerce Parkway. JobsOhio is offering grant and low-interest loan opportunities for qualifying projects. As companies look to onshore manufacturing and improve their supply chain for parts, we see our region as an ideal location. The 19+ acres along Commerce will allow for at least one 100,000 sf building with room to expand.

applauded; we know economic development is a team effort.

The AEDG team and our partners worked on development projects that totaled more than \$250 million of capital investment by businesses in our county. Even with employment fluctuating throughout the year, we still had many of our top employers creating jobs.

I want to highlight a couple of successes. In the first two quarters of the year, Ohio Cat established their business on Bluelick Road off I-75. It was also announced in July that Logoplaste, a Portugalbased manufacturer chose Allen County for its next facility with the goal of full operation in the first quarter of 2021.

Existing companies such as Randall Bearings, Perry ProTech, and Beer Barrel announced plans to build facilities in our area. Finally, several of our largest employers have made significant capital investments, which will lead to increased employment.

In casting the vision for the future of Lima/Allen County we believe that we are positioned well for success. Our location, our infrastructure, our workforce, and our business climate are primed for development. Let's have a productive 2021 together.

Another goal is to construct an 80,000-100,000 sf building at the site that formerly housed the EDCO fabrication company on Kibby Street. AEDG is actively trying to find an occupant for a new building. Finding a tenant will make the project eligible for the JobsOhio revitalization program and open funding to complete the remediation of the 11+ acre site. The Port Authority of Allen County has an option on the land and has completed several environmental studies on the parcel. The city has also made some investment in the lot. A plan for the location is needed before December, the expiration of the port authority's option to buy.

Alexander is the site engineering director the Lima Proctor and Gamble plant. He has had several leadership and

management roles during his more than 20 years with P&G, the global producer of household products. He started at the Lima facility in March 2019.

The new members will serve until December 2023. They replace Don Klausing, Hydrofresh HPP, Delphos, who was term-limited off the board, and Perry Wiltsie, Vanamatic, Delphos, who resigned.

As always, we will continue to make visits to our existing companies to learn more about the obstacles they face and the goals they are trying to accomplish. - In March, Governor Mike DeWine announced the creation of BroadbandOhio, an office dedicated to improving access to high-speed internet across Ohio, especially to the estimated 300,000 households without it. In December, InnovateOhio released the Ohio Broadband Strategy, which among other things calls for the creation of a telehealth initiative, defines a pathway to expand access to state-owned rights of way, and utilizes the Common Sense Initiative (CSI) to improve the regulatory environment associated with expanding services.
- The Ohio Tax Credit Authority approved a clawback agreement with GM under which the automaker will repay \$28 million in incentives as a result of the idling of its Lordstown assembly plant in 2019, and another \$12 million in "Ohio Community Support" in the form of scholarships or job training at Youngstown State University or other schools in the region. In a related action, the Tax Credit Authority approved a 15-year, 1.95% job creation tax credit to Ultium Cells — a new joint venture between GM and South Koreanbased LG Chem — to manufacture electric vehicle battery cells at the same Lordstown facility, where Ultium aims to create 1,000 full-time positions.
